

# **HIGHLIGHTS**

Process of sharing experience and lessons-learnt from the Phase I and planning of Phase II has started Meetings are taking place all across the Platform on Human Health (PHH) to discuss the progress and lessons learnt from Phase I and to initiate planning of Phase II activities and budgets.

The plans and priorities at partnership level will feed into a joint Building Stronger Universities (BSU) Phase II proposal – covering the period August 2013 to July 2015 – that will be submitted to the Danish Rectors' Conference and subsequently to the Ministry of Foreign Affairs for approval in April and May.

Grant for Capacity Building within Research Communication, Dissemination and Networking
The Danish Ministry of Foreign Affairs (MoFA) has approved the additional DKK 19 mill. grant for Capacity
Building within Research Communication, Dissemination and Networking to be shared between the four
BSU platforms. The detailed planning of the activities will take off in the beginning of 2013. One built in
objective is to strengthen collaboration across the four thematic BSU platforms on generic activities
including Problem Based Learning and e-learning.

# PROGRESS / UPDATE ON ACTIVITIES

Phase I activities are progressing timely and according to plans. However all PhDs have been delayed. Status of the 10 PHH supported PhD projects five PhD students are now registered at UG, two at KNUST, and two at KCMC, while the identified PhD student from ZCHS to be registered at KCMC is still working on her proposal.

There are similar delays across the other BSU platforms in general due to changes in PhD programme guidelines and a too optimistic timeline in comparison to how long it actually takes to announce the PhD fellowships, for qualified candidates to produce and present relevant proposals, then to be formally approved and registered. In response to this situation, the Ministry of Foreign Affairs has agreed to extend PhD related budgets in BSU Phase I as required.

### **GHANA**

### University of Ghana (UG) and Kwame Nkrumah University of Science and Technology (KNUST)

The joint PHH Ghana Implementing Committee and the PHH coordinator shared experience and lessons-learnt from Phase I and agreed upon the process of preparing the Phase II proposal in a video conference held on 12 December.



#### **TANZANIA MAINLAND**

### Kilimanjaro Christian Medical Centre (KCMC) and National Institute of Medical Research (NIMR)

In December, Peter Furu replaced Niels Ørnbjerg as the Post Graduate Education Work Package Leader in the North Tanzania Team. Ben Hamel, Institutional Capacity Work Package Leader in the South Tanzania Team is leaving his position as Director of Postgraduate Studies at KCMC. A replacement for him in the PHH has yet not been identified.

In November, Helle Trøst Nielsen and Shirley Pollak met with management, faculty members and postgraduate students at KCMC to assess the needs for strengthening the postgraduate office and the quality assurance system for postgraduate programmes at KCMC.

Also in November, core members of the Danish PHH Tanzania team, Thor Theander and Dorte Holler Johansen, met with PHH representatives at KCMC, including Gibson Kibiki, Ben Hamel, Frank Mosha, Ahaz Kalunga, Mosha Ntabaye and Jim Todd to initiate sharing of experience from Phase I and planning for Phase II. A follow up meeting will be scheduled early 2013.

In December, Peter Furu facilitates a course on Research Management & Leadership at KCMC together with Frank Mosha.

#### **ZANZIBAR**

#### State University of Zanzibar (SUZA) and Zanzibar College of Health Sciences (ZCHS)

Early December, Mona-Lisa Dahms from Aalborg University facilitated an initial session on Problem Based Learning (PBL) for staff members from SUZA and ZCHS. There will be follow up training in 2013 and the aim is gradually to start implementing PBL in the academic year 2013/2014 and to expand support to PBL activities according to priorities in future activity plans.

PHH Coordinator Bjørg Elvekjær and Zanzibar Implementing Committee representative Henrik Bregnhøj visited Zanzibar mid December to discuss progress of Phase I activities and priorities for Phase II with the PHH Zanzibar team and the management at SUZA and ZCHS.
